# Corrigendum to the 2025 Erasmus+ Programme Guide

This Corrigendum comprises changes related to:

- Accreditation validity in the fields of school, vocational and adult education
- Not-for-profit European sport events
- Operational capacity

All the changes above are reflected in the version 2 of the 2025 Erasmus+ Programme Guide, available on the Erasmus+ website of the European Commission.

## Changes related to accreditation validity in the fields of school, vocational and adult education

**Page 78:** Correction of validity start date.

### VALIDITY

The validity of Erasmus accreditations awarded under this call for proposals will start on 1 February ~~2025-2026~~ and continue for the duration of the current programming period until 31 December 2027.

## Changes related the Erasmus Mundus Action

**Page 285:** Correction of NDICI budget percentage.

### ADDITIONAL FUNDS FOR STUDENTS FROM TARGETED REGIONS OF THE WORLD

(...)

The geographical targets and indicative budget share set for this action are the following:

- Region 1 (Western Balkans): Particular focus will be on scholarships in the fields of climate change, environment and energy, digital technologies, engineering, sustainable growth and jobs.
- Region 3 (Neighbourhood South): 8% of the budget available from NDICI. ~~2230~~% of this amount should be allocated to Tunisia.

## Changes related to Not-for-profit European sport events

**Page 353:** Expanding the objectives of the action:

### OBJECTIVES OF THE ACTION

(...)

The project has to focus on one of these objectives. It can also focus on the remaining objectives, but the main objective must be clearly identifiable and prevailing in the proposal.

It provides financial support for the organization of one European-wide sport event in one EU Member State or third country associated to the Programme or for the organisation of European local events in several EU Member States and third countries associated to the Programme.

This action also supports Large-scale European sport events that aim to reach a very high impact and implement follow up activities to ensure legacy in terms of societal benefits and promotion of inclusion through sport, in particular fostering the inclusion of people with disabilities.

Page 353-354: Fine-tuning the eligibility criteria:

## ELIGIBILITY CRITERIA

(...)

<p><b>Consortium composition</b></p>	<p>A Not-for-profit European Sport Event is transnational and involves:</p> <ul style="list-style-type: none"><li>• <b>For the European local event (Type I):</b> involves between 3 and 5 organisations. Each organisation must come from different EU Member States and third countries associated to the Programme.</li><li>• <b>For the European local event (Type II):</b> a minimum of 6 organisations coming from 6 different EU Member States and third countries associated to the Programme</li><li>• <b>For the European-wide event:</b> a minimum of 10 organisations (1 single applicant + 9 participating organisations presented as associated partners) coming from 10 different EU Member States and third countries associated to the Programme.</li><li>• <b>For the Large-Scale European event:</b> a minimum of 15 organisations (1 single applicant + 14 participating organisations presented as associated partners) coming from 15 different EU Member States and third countries associated to the Programme.</li></ul> <p>The consortium composition must meet the requirement for the grant requested.</p>

<p><b>Eligible activities</b></p>	<p><b>For the European local events (Type I and II)</b> the activities must take place in each EU Member State or third country associated to the Programme involved in the Not-for-profit European Sport Event.</p> <p><b>For the European-wide event</b>, the activities must take place in the EU Member State or third country associated to the Programme of the applicant organisation involved in the Not-for-profit European Sport Event.</p> <p><b>For the Large-Scale European event</b>, the activities must take place in 2025 in a EU Member State or in a third country associated to the Programme. These sport events must showcase a minimum of 7 different sports and must include activities implemented throughout the year following the event, to ensure its legacy in terms of societal benefits (e.g. social, educational, environmental, health) and promotion of inclusion through sport.</p>
<p><b>Duration of project</b></p>	<p>Projects should normally last 12 or 18 months, based on the objective of the project and on the type of activities foreseen over time. Extensions are possible, if duly justified and through an amendment of the grant agreement.</p>
<p><b>Where to apply?</b></p>	<p>To the European Education and Culture Executive Agency (EACEA).</p> <p><b>For the European local event (Type I and II) and for the European-wide event:</b></p> <ul style="list-style-type: none"> <li>• Call ID: ERASMUS-SPORT-2025-SNCESE.</li> </ul> <p><b>For the Large-Scale European event:</b></p> <ul style="list-style-type: none"> <li>• Call ID: ERASMUS-SPORT-2025-LSSNCESE.</li> </ul>

**Page 353-354:** Fine-tuning the funding criteria:

#### **WHAT ARE THE FUNDING RULES?**

The contributions for Not-for-profit European Sport Events take the form of lump sums, with the exception of the Large-Scale European event category. The amount of the fixed lump sum depends on the number of events and number of organisations involved in the project.

#### **d) For Large-Scale European events**

The grant amount is expected to range between EUR 1,5 million and 2 million. The grant awarded may be lower than the amount requested.

The grant will be budget-based, with actual and unit costs as well as flat-rate elements. It will support certain types of eligible costs actually incurred for the projects.

The detailed grant parameters (maximum grant amount, funding rate, eligible costs, etc.) will be fixed in the Grant Agreement. The costs will be reimbursed at the funding rate fixed in the Grant Agreement (80%).

Financial support to third parties is not allowed. Volunteer and SME costs are allowed. Please refer to Part C of this Programme Guide, to the section on 'Eligible Direct Costs'.

## Changes related to operational capacity

**Page 415:** Adjustment of mandatory supporting documentation.

If the grant exceeds 60 000 EUR, applicants must submit with the application:

- ~~CVs of the key persons involved in the project to demonstrate their relevant professional experience;~~
- a list of relevant publications of participating organisations;<sup>465</sup>
- an exhaustive list of previous and ongoing projects and activities performed and connected to the policy field or to the specific action.

In case of doubt,<sup>466</sup> the National Agency may also use other sources of information, such as findings of previous audits, feedback (including from other National Agencies) from the management of previous or current projects, reports of monitoring visits or information from the organisation's website or social media profiles in order to assess the operational capacity and ability to obtain it. The National Agency may also ask for additional supporting documents and information to verify the information included in the application (such as CVs of the key persons involved in the project to demonstrate their relevant professional experience).
